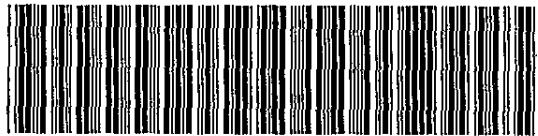

ARTICLES OF INCORPORATION

OF

JERRY A. WEISSINGER PAINTING, INC.

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is JERRY A. WEISSINGER, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose for which the corporation is organized are to engage in any activity or business permitted under laws of the United State and of this state.

FOURTH: Authorized Shares.

Number. The aggregate number of shares that the corporation shall have the authority to issue is 200 shares of Capital Stock with a par value of one dollar per share.

Initial issue. Two hundred shares of the Capital Stock of the corporation shall be issued for cash at a par value of one dollar per share.

State capital. The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

Dividends. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

No classes of stock. The shares of the corporation are not to be divided into classes.

No shares in series. The corporation is not authorized to issue shares in series.

FIFTH: The initial street address in Florida of the initial registered office of the corporation as 5056 Plantation Drive, Lakeland, Florida 33811 and the name of the initial registered at such address is Jerry A. Weissinger.

SIXTH: The initial board of directors shall consist of ONE (1) member(s). Directors need not be residents of the State of Florida or shareholders of the corporation.

SEVENTH: The names and address of the persons who shall serve as directors until the first annual meeting of shareholders, or until successors shall have been elected and qualified, are as follows:

EIGHTH: The names and addresses of the initial incorporators are as follows:



NINTH: An affirmative vote of two-thirds of the shares of the corporation shall be required for any shareholder action. A unanimous vote shall be required for election of S Corporation status.

TENTH: The stockholders shall have the power to adopt, amend, alter, change, or repeal the articles of incorporation when proposed and approved at a stockholders meeting, with not less than a majority vote of the common stock.

ELEVENTH: The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of stock of this corporation as may be issued for money, or any property or services from time to time, in addition to that stock authorized by the corporation. The preemptive right of any holder is determined by the ration of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.
