# ARTICLES OF INCORPORATION OF MOSTAR CORPORATION

#### ARTICLE I NAME & ADDRESS:

The name of this corporation is Mostar Corporation and the address is 9110 SW 45 Terrace, Miami, Florida 33165.

#### ARTICLE II DURATION

This corporation is to exist perpetually and it shall commence its existence on the state of date of filing of the Articles of Incorporation with the Secretary of the State of Florida.

### ARTICLE III PURPOSE

#### ARTICLE IV CAPITAL STOCK

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniary or otherwise interested in, or are directors or officers of such other corporation; any director individually, or any firm of which any director may be a member, may be a part to, or any may be pecuniary or otherwise interested in, any contract to transaction of the corporation, provided that the fact be, or such firm so interested shall be disclosed or shall have been known to the Board of Directors or such members thereof as shall be present at any meeting of the Board of Directors at which action upon any such contract or transaction shall be taken; and any director of the corporation which is also a director or officer of such other corporation or is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize any such contract or transaction with the like force and effect as if her were no such director or officer as such other corporation or not so interested.
