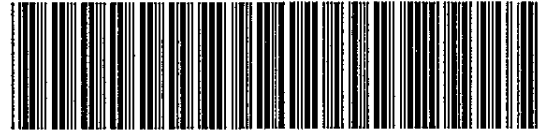

ARTICLES OF INCORPORATION OF

John Peifer and Company, Incorporated

The undersigned, acting as director(s) for the purpose of forming a corporation in accordance with the Laws of the State of Florida, adopt(s) the following Articles of Incorporation.

ARTICLE I Name

The name of the corporation shall be **John Peifer and Company, Incorporated.** and its initial place of business shall be at **6502 SE Clairmont Place** in the City of **Hobe Sound**, in the County of **Martin** and State of **Florida**. These Articles shall be (effective upon filing *or* specify the effective date).

ARTICLE II Purpose

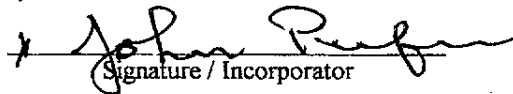
