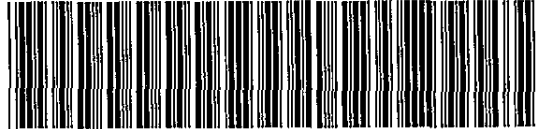



**ARTICLE I - NAME**

The name of this Corporation is OUTDOOR LIFESTYLE PROPERTIES, INC., and the principal business and mailing address of the Corporation is 397 Lolly Lane, Jacksonville, Florida 32259.


