



ARTICLES OF INCORPORATION

OF

WRL STRATEGIC SERVICES, INC.



THE UNDERSIGNED, for the purposes of forming a corporation under the Florida

General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the corporation is WRL Strategic Services, Inc.
