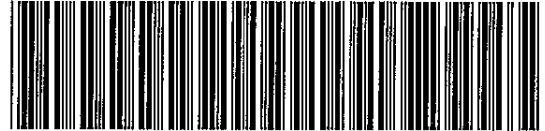

**ARTICLES OF INCORPORATION  
OF  
GUNFLINT INVESTMENTS, INC.**

The undersigned, acting as the Incorporator of GUNFLINT INVESTMENTS, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the *Florida Statutes*, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following *Articles of Incorporation for the Corporation*:

**ARTICLE I - NAME**
