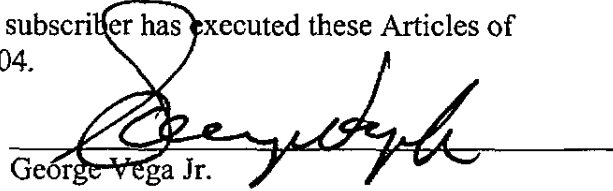
- ARTICLE I:** Name. The name of the Corporation is George Vega Jr. P.A.

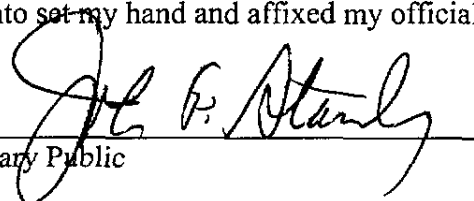
