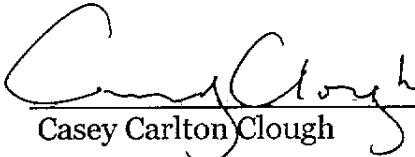

Amendments

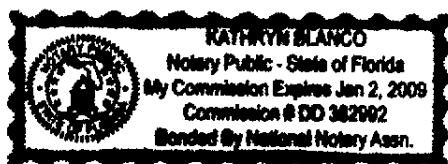

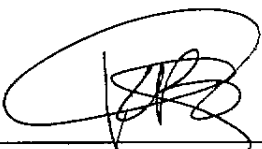

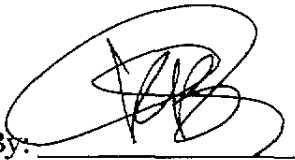
