**ARTICLES OF INCORPORATION
OF
HATTENDORF LAND SURVEYING, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the Florida Business Corporation Act ("Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation ("Corporation") is: HATTENDORF LAND SURVEYING, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
