4. **ARTICLE IV TERM**

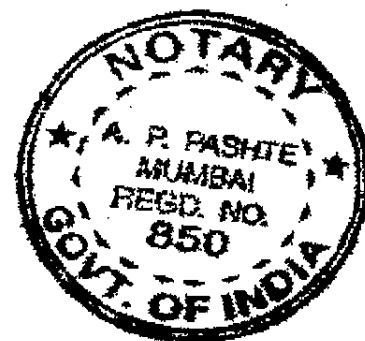
This corporation shall have perpetual existence.

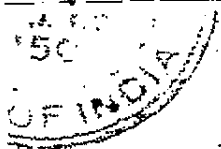

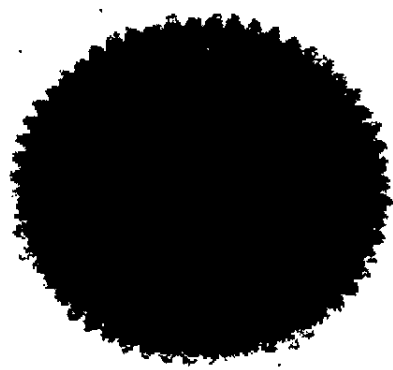
