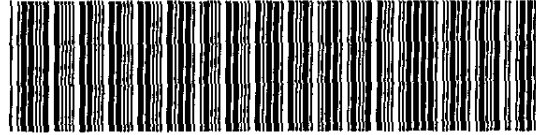



**Name**
