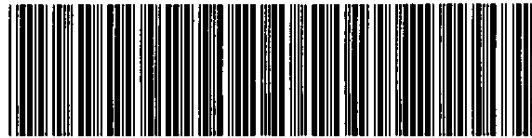

RESIGNATION OF REGISTERED AGENT FOR A FLORIDA CORPORATION


