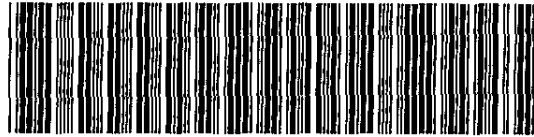



INDEMNIFICATION


