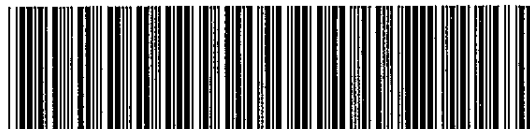

The undersigned natural person of the age of twenty-one or more, acting as Incorporator under the provisions of the Florida Statutes, Chapter 607, adopts the following Articles of Incorporation:

ARTICLE I
Name

The name of this corporation shall be:

GDI Trading, Inc.

ARTICLE II
Principal Place of Business

The principal place of business is to be located at:

ARTICLE III
Term of Existence

The duration of this corporation is to be perpetual.

ARTICLE IV
Purpose

Engage in such business or businesses as may be approved by the Board of Directors and which businesses are permitted by the laws of the State of Florida.
