ARTICLES OF INCORPORATION

OF

MOSHE SAS, P.A.

The undersigned natural person, being licensed to practice the profession of real estate sales in

the State of Florida, hereby declares the intention of forming a professional corporation in accordance

with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of

Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is MOSHE SAS, P.A.

ARTICLE II. PURPOSE

This corporation is organized for the following purposes:

To engage in the practice of real estate as a professional corporation.

estate is not less than FIVE HUNDRED (\$500.00) DOLLARS.
