

**ARTICLES OF INCORPORATION
OF
LACEY FENCING & DECKS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: LACEY FENCING & DECKS, INC., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

ARTICLE II

The street address of the principal office of the Corporation is: 5711 Government Drive, Gulf Breeze, Florida 32563.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, with 500 shares to JACK LACEY.
