**ARTICLES OF INCORPORATION**  
*of*  
**JAMES ROACH, P.A.**

THE UNDERSIGNED, being of legal age and natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Professional Association under the laws of the State of Florida.

**ARTICLE I**

The name of this Professional Association shall be JAMES ROACH, P.A.

**ARTICLE II**

The specific purpose of this Professional Association is that of a realtor and as such may engage in any activity or business permitted under the Laws of the State of Florida.

**ARTICLE III**

The capital stock authorized, the par value thereof, and characteristics of such stock shall be as follows:

All of said stock should be payable in cash, property, real or personal, labor of services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Professional Association. The payment thereof does not have to be at the time of issuance, provided that said shares are subject to calls thereon until the while consideration therefrom shall have been paid. There shall be 1,000 shares of stock at the initial authorized number of shares at no par value.

#### **ARTICLE IV**

The amount of capital stock which this Professional Association shall commence business shall not be less than Five Hundred and No/100 (\$500.00) Dollars.

#### **ARTICLE V**

The Registered Office and the Registered Agent for services in the State of Florida shall be Dean J Trantalis, Esq., 2255 Wilton Drive, Wilton Manors, FL 33305.

The principal office of this Professional Association shall be located at 1125 NW 30<sup>th</sup> Court, Suite 4, Wilton Manors, FL 33311.

The Board of Directors may vote from time to time to move the post office address and principal office to any other address in the State of Florida.

#### **ARTICLE VI**

This Professional Association shall have no less than one (1) nor more than three (3) directors. The number of directors may be altered from time to time by the Bylaws adopted by the stockholders. The name and post office address of the Officers and Directors are:

The members of the first Board of Directors shall hold office until the first annual meeting of the stockholders of this Professional Association.


#### **ARTICLE VII**

However, in lieu of the above-described procedure, an amendment may be made by a written instrument signed by all of the directors and stockholders of the Professional Association.


