ARTICLES OF INCORPORATION

of

JAMES ROACH, P.A.

THE UNDERSIGNED, being of legal age and natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Professional Association under the laws of the State of Florida.

ARTICLE I

The name of this Professional Association shall be JAMES ROACH, P.A.

ARTICLE II

The specific purpose of this Professional Association is that of a realtor and as such may engage in any activity or business permitted under the Laws of the State of Florida.

ARTICLE III

The capital stock authorized, the par value thereof, and characteristics of such stock shall be as follows:

All of said stock should be payable in cash, property, real or personal, labor of services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Professional Association.
