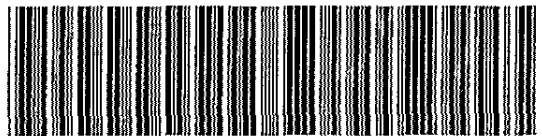

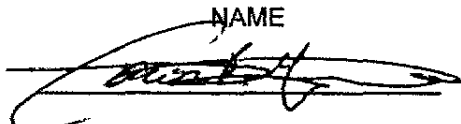

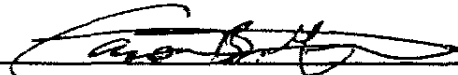
mandatory in all circumstances in which indemnification is permitted by the laws or statutes of Florida.

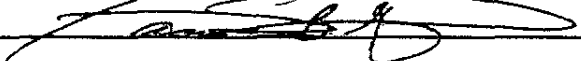
