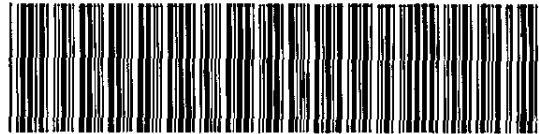

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("the Corporation") is **Susan Strube Inc.**

**ARTICLE II**

The street address and mailing address of the principal office of the Corporation is 2308 S.E. 30<sup>th</sup> Street, Melrose, Florida 32666.

**ARTICLE III**

The Corporation is authorized to issue Fifty Thousand (50,000) shares of common stock having a par value of One Cent (\$.01) per share.

**ARTICLE IV**

The street address of the Corporation's initial registered office is 420 South Lawrence Boulevard, Keystone Heights, Florida 32656. The initial registered agent for the Corporation at that address is James J. Taylor Jr.

**ARTICLE V**
