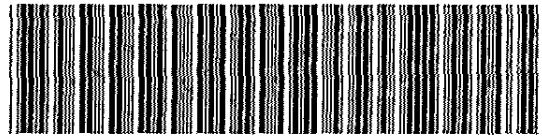

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
SPELIOS DENTAL CENTER – OLD CUTLER, P.A.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Professional Association hereby adopts the following amendment to its Articles of Incorporation:

**I.**

The name of the corporation is: SPELIOS DENTAL CENTER – OLD CUTLER, P.A.

**II.**

Article I of the corporation's Articles of Incorporation, having an effective date of March 24, 2005, is hereby deleted in its entirety and replaced by the following:

The foregoing amendment was adopted by the written consent of the corporation's sole director on April 27, 2005.


**IV.**
