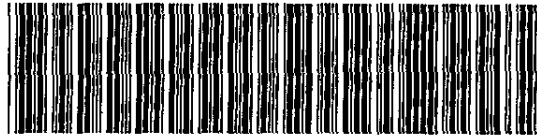

**ARTICLE IV- NEW NAME**




