ARTICLES OF INCORPORATION OF SUNFRESH GOURMET, INC 1323 Franford Drive Brandon, FL 33511

The undersigned has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE ONE

The name of this corporation shall be SUNFRESH GOURMET, INC, 1323 Franford Drive Brandon, FL 33511.

ARTICLE TWO

This corporation shall commence existence effective March 17, 2005 upon filing these Articles of Incorporation by the Department of State, the State of Florida, and shall have perpetual existence.
