The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be **NO STRESS, INCORPORATED**

**ARTICLE II  
PRINCIPAL OFFICE**

**ARTICLE III


