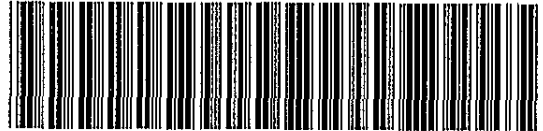

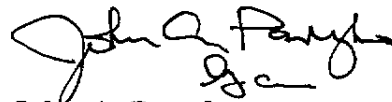

OF

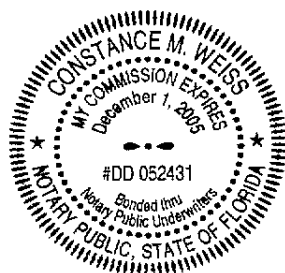

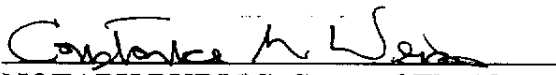
