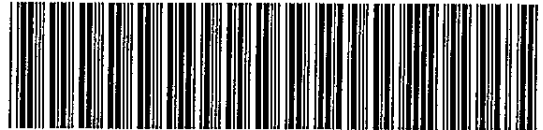

ARTICLES OF INCORPORATION

OF

BEINKEMPER, INC.

(A Florida Corporation for Profit)

The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

CORPORATE NAME AND PRINCIPAL OFFICE

The name of the corporation is BEINKEMPER, INC., and its principal office is 22 Mooney Road, Ft Walton Beach, FL 32547.

ARTICLE TWO

NATURE OF BUSINESS

The purpose of the corporation is to do any and all lawful business for which corporations may be incorporated under the laws of Florida. The initial purpose of this corporation is a food service business.

ARTICLE THREE

CAPITAL STOCK

The corporation is authorized to issue One Thousand ( 1,000 ) shares of stock with a par value of one dollar ( \$ 1.00 ) each. Such stock shall be of a single class.

REMOVAL OF DIRECTOR



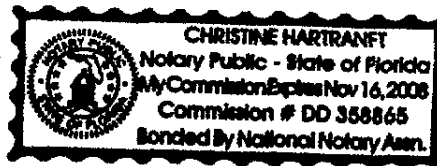


