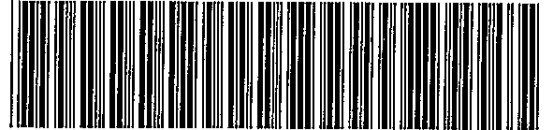

**ARTICLES OF INCORPORATION
OF
L. FERNANDO NARVAEZ, M.D., P.A.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is L. Fernando Narvaez, M.D., P.A. (hereinafter called the "Corporation").

**ARTICLE II
PURPOSE**

The purpose of the Corporation and the nature of its business are as follows:

1. To practice medicine involving the diagnosis, treatment, operation, and/or prescription of medicine concerning any human disease, pain, injury, deformity, or other physical or mental condition as defined in 32 F.S. § 458.305(3) (2004), and to be performed by a Florida State licensed physician Fernando Narvaez, M.D., and any other Florida State licensed physician(s) who may join the professional association in the future pursuant to 32 F.S. § 458.305(4) (2004).
2. To do everything necessary, proper or convenient for the accomplishment of such purpose, and to do every other act incident thereto which is lawfully permitted.

**ARTICLE III
PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE IV
CAPITAL STOCK**

The number of shares of stock that the Corporation is authorized to issue is one thousand (1,000) shares, \$ 1.00 par value per share, of common stock. Each issued and outstanding share of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.
