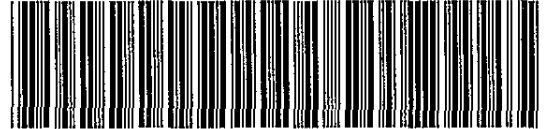



**ARTICLE ONE


