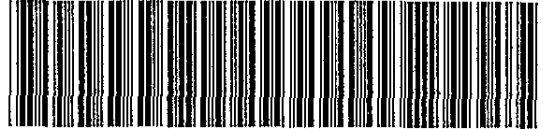

ARTICLES OF INCORPORATION  
Pursuant to Chapter 607 and 621 Florida Statutes, F.S.

ARTICLE I – NAME

The name of the corporation shall be: Sunset Party Cat, Inc.

ARTICLE II- PRINCIPLE OFFICE

The mailing address of the corporation is P.O. Box 2185, Key West, Florida 33045-2185

ARTICLE III - PURPOSE

The general nature of the business proposed to be transacted, promoted and carried on are to do any and all things hereinafter mentioned as fully and to do the same extent as natural persons might or could do, namely:

The organization will own and operate party boats for profit and any other business it desires that are legal under Florida Statutes.

ARTICLE IV – STOCK

The amount of authorized capital stock of this corporation shall be ten thousand (\$10,000) shares. The shares shall have a par value of One Dollar (\$1.00) each.

The capital stock may be paid for in property, labor or services at a just valuation to be fixed by the incorporator at the organization meeting. Fractional shares of stock may be issued.
