ARTICLES OF INCORPORATION

OF

BRALEY CARROLL INVESTMENTS, INC.

The undersigned, for the purpose of forming a Corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

- Section I.1 Name. The name of the corporation is Braley Carroll Investments, Inc. (the "Corporation").
