ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - NATURE OF BUSINESS

This corporation shall have perpetual existence.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock..

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock or authorized but issued stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly may be done without issuance of fractional shares) at the price at which it is offered to others.

This corporation shall indemnify any officer or director, or any former officer or director to the full extent permitted by law.


ARTICLE XI - AMENDMENT
