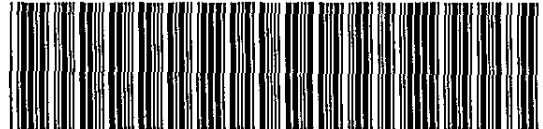

ARTICLES OF INCORPORATION

OF

Ringemann Accounting, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation is:

Ringemann Accounting, Inc.

ARTICLE II – ADDRESS

The street address of the initial registered office of this corporation is 1819 Grouper Dr. Ocean, Marathon, Florida 33050. The name of the initial registered agent of this corporation at the aforesaid street address is: Robin Ringemann

ARTICLE III – NATURE OF BUSINESS

The purpose or purposes for which the corporation is organized is to operate accounting/office service permitted under the Law of the State of Florida and of the United States of America; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, or cemetery company, a building and loan association, mutual life insurance association, cooperative association, fraternal benefits society, state fair or exhibition.

ARTICLE IV – CAPITAL STOCK

The maximum numbers of shares of stock that this corporation is authorized to have outstanding at any one time is Fifty Thousand (50,000) shares of common stock, all of which are to be of One Dollar (\$1.00) par value each.

The consideration for the issuance of the aforementioned shares or for the disposal of treasury shares may be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services performed for the corporation. Shares may not be issued until the full amount of the consideration for which the shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and non-assessable and exempt from assessment.

This corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.


ARTICLE X – AMENDMENT



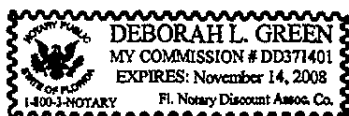


