ARTICLE VII – INCORPORATOR

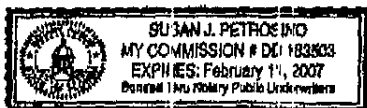


