CERTIFICATE OF INCORPORATION OF ABC COMPUTERS PARTS AND SOLUTIONS, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities and liabilities of incorporation for profit.

ARTICLE I

The name of this corporation should be:
