QCFC provides financial appraisals of closely-held, privately-owned corporations that involve estate planning for corporate owners.

QCFC is authorized to have 500 shares of common stock. John F. Bohmfalk is President of QCFC and is the sole owner.

QCFC produced 16 financial appraisals in 2005, of which six involved valuations of companies, with the remaining ten providing valuations for estate planning purposes. Our principal source for these appraisals is the Cincinnati law firm of Buechner, Haffer, O'Connell, Meyers & Koenig Co.

The total financial receipts for 2005 appraisals reached \$7,575, up 36% aided by an improved economy, while expenses rose 7.5% to \$5,364. Ordinary business income therefore amounted to \$2,211 as reported in the QCFC income tax report.
