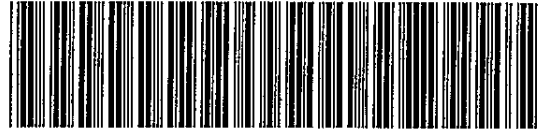

NAME

The name of this corporation is CORAX SERVICES, INC.

ARTICLE II

PRINCIPAL OFFICE

BUSINESS TO BE TRANSACTED

The nature of the business to be transacted by the corporation is:

To engage in real estate transactions.




