

ARTICLES OF INCORPORATION

OF

BRYAN ELECTRICAL SERVICES, INC.

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **BRYAN ELECTRICAL SERVICES**, **INC.**, and its principal place of business shall be located at <u>1859 Caravan Trail</u>, <u>Unit 104</u>, <u>Jacksonville</u>, <u>Florida 32216</u>.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business relating to electrical services, residential and/or commercial.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1000) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is <u>7602</u> Fawn Lake Drive, North, Jacksonville, Florida <u>32256</u>, and the name of the initial registered agent of this corporation at that address is Bryan A. Thomas.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have <u>two</u> (2) <u>Directors</u> who shall serve until their successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors.
