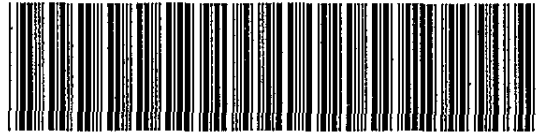

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is MATT RAULERSON LANDSCAPING SERVICE, INC., whose business address is 511 East Macclenny Avenue, Macclenny, Florida 32063; and mailing address is 511 East Macclenny Avenue, Macclenny, Florida 32063.

ARTICLE TWO

CORPORATE DURATION

The duration of the corporation is perpetual. The business is to begin upon filing these articles.

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

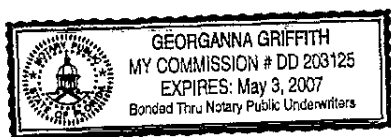
