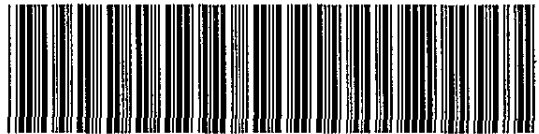

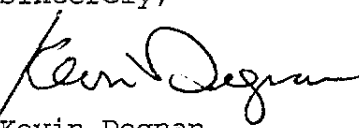

ARTICLES OF INCORPORATION

SEA WAVE HAIR & NAILS, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

ARTICLE 1

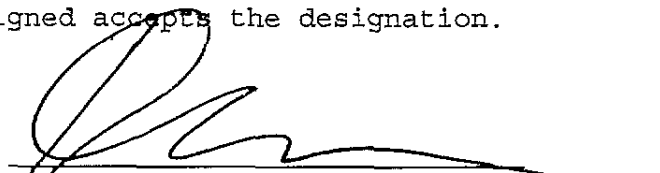
