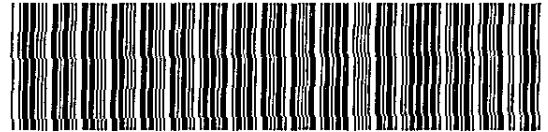

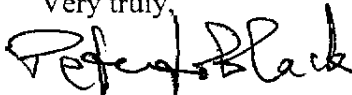

ARTICLE I

The name of the corporation is **HOME BOUND CARE OF SOUTH FLORIDA, INC.** (hereinafter called the ("Corporation")).

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 340 N.W. 183rd Street, Miami, FL 33169.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE V

The street address of the Corporation's initial registered office is c/o Law Office of Peter Loblack, P.A., 2835 Hollywood Blvd., Suite 300, Hollywood, FL 33020, and the name of its initial registered agent at such office is Peter Loblack.

ARTICLE VI

The Board of Directors of the Corporation shall consist of at least one director. Directors shall be elected by the shareholders in accordance with the provisions in the Bylaws and shall serve for a term of two years. The initial directors of the Corporation are:
