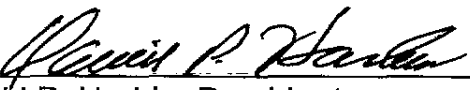
SECOND: The date of the adoption of these Articles of Dissolution is August 5 2005.
