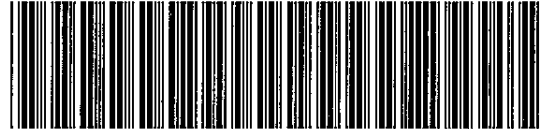



Article XIII – Amendment


