ARTICLES OF INCORPORATION

OF

LAW Environmental Services, Inc.

The undersigned, for the purpose of forming a Corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

- Section 1.1 Name. The name of the corporation is LAW Environmental Services, Inc. (the "Corporation").
