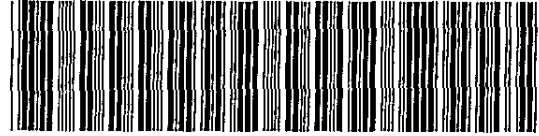



The name of the corporation is G & J TILE, INC.


