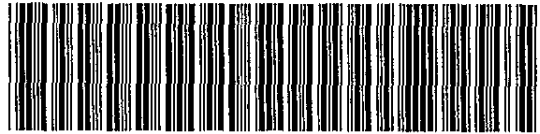


ARTICLE VIII
