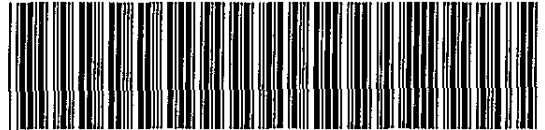

**ARTICLES OF INCORPORATION
OF
ROB'S PRECISION FLOORING, INC.**

We, the undersigned incorporators, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name and Mailing Address

The name of this corporation shall be:

ROB'S PRECISION FLOORING, INC.

The address of the principal office and the mailing address of the corporation is:

Existence of Corporation

This corporation shall begin existence upon the filing of these Articles with the Secretary of State of the State of Florida and shall thereafter have perpetual existence.

ARTICLE III

Purposes

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

Powers

This corporation shall have all such powers as may be necessary or desirable to carry out the business of the Corporation, including, but not limited to all those powers enumerated by §607.0302, Florida Statutes (2002), as may be amended from time to time.

ARTICLE V

Capital Stock

(a) The corporation shall have a single class of common stock, all having the same rights and privileges.

(b) The total number of shares of stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in chase, by promissory note, in property, in labor or services actually performed for the Corporation or promised to be performed as evidenced by written contract, valued at a fair valuation to be fixed by the Board of Directors at a meeting called fur such purpose. All stock when issued shall be paid for and shall be nonassessable.

©) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

(d) There shall be no preemptive rights granted to the holders of any stock in the corporation.

ARTICLE VI

Registered Office and Registered Agent

The street address of the corporation's initial registered office is: 2575 Ulmerton Point, Suite 230, Clearwater, Florida 33762 and the name of the corporation's initial registered agent at such address is: Robert M. Todd, Esquire. The corporation may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with §607.0502, Florida Statutes (2002), as may be amended from time to time.

ARTICLE VII

Initial Board of Directors

The number of directors constituting the initial Board of Directors shall be one (1), and the name and address of such person who is to serve as the member thereof is as follows:


