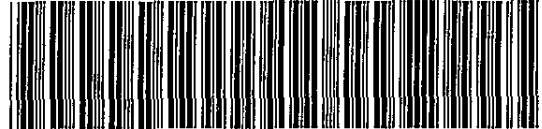

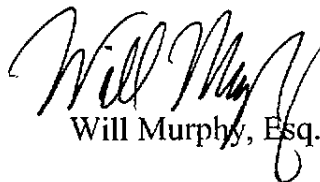

ARTICLE I: CORPORATE NAME

The name of this corporation is Huasca Productions, Inc.

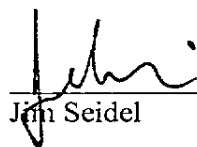

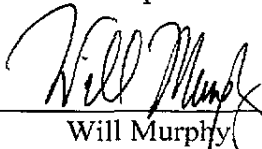
