We, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be:

ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III

The aggregate number of shares which the Corporation shall have authority to issue is one million (1,000,000) common shares, having a par value of \$.001 per share, that may be issued from time to time as determined by the Corporation's Board of Directors.

ARTICLE IV

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE V

The initial registered office of this Corporation shall be 301 Yamato Road, Suite 3160, Boca Raton, Florida 33431, with the privilege of having its offices and branch offices at other places within or without the State of Florida. 
ARTICLE X
