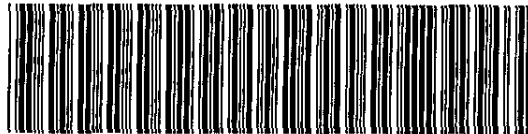

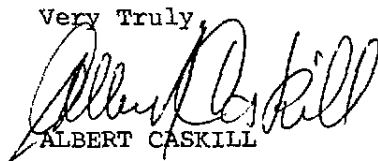

THE UNDERSIGNED for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I
NAME OF CORPORATION**

The corporation name is CASKILL & SONS ALUMINUM, INC., and the mailing address of the corporation is 3581 – 52 Avenue North, St. Petersburg, Florida 33714.

**ARTICLE II
DURATION**

The duration of the corporation is perpetual.

**ARTICLE III
PURPOSE**
