#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

#### ARTICLE ONE

The name of the corporation is Miami Automotive & Tires Corp

#### ARTICLE TWO

The duration of the corporation is perpetual.
